

ELIGIBILITY

“Q-95.9’s MONEY MACHINE CONTEST”

NO CONSIDERATION OR PURCHASE IS REQUIRED TO ENTER OR WIN. CONSIDERATION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

This contest is open to California residents age 18 or older. Employees of Point Broadcasting LLC (PBLLC), dba Gold Coast Broadcasting and affiliated companies, contest sponsors and their respective household or immediate family members, are not eligible to enter. Compliance with the eligibility requirements will be determined solely by Point Broadcasting LLC/Gold Coast Broadcasting. All Federal, State and local laws and regulations apply. HOW TO ENTER

Potential contestants of “Rico & Mambo’s Money Machine” must listen to Q95.9 (KCAQ-FM) for a sounder cue to be the designated caller at random times in the designated hours at approximately 7:05am, 8:05am and 9:05am, Monday through Friday from Monday, April 2, 2018, through Friday, May 4, 2018. Designated callers will win \$100. Once the designated caller is on the line they will have the option of keeping their \$100 or forego it for the chance to win a bigger prize by opting to “spin the wheel”. If the caller chooses to “spin the wheel” they will then select a member of the Q95.9 morning show to “spin the wheel” on their behalf. When the “wheel” stops the winner will win the indicated prize. The prizes will vary from zero up to \$500 and various other prizes including concert tickets and theme park tickets. The prize indicated when the wheel stops will be the only prize awarded to the contestant. There will be a total of three (3) winners each weekday for the five (5) week duration of the contest. There will be a total of forty-five (45) winners during the five (5) week duration of the contest. There is a limit of one qualifying winner per family or household.

2. Recorded promos will begin on Saturday, March 31, 2018, and will air numerous times randomly between 6am and 10pm throughout the duration of the contest. The promos will highlight how the contest works and will direct listeners to the KCAQ website (www.q959.fm) for complete contest rules which will be prominently identified on the website
